



1000/1650 Freestyle Time Trial February 24, 2008

- SANCTION:** Held under USA-S/Sierra Nevada Swimming Sanction # 16-08
- LOCATION:** Woodland Community Swim Center, 155 N. West Street, Woodland, CA 95695. From I-5 north or south, take the West Street exit; travel 1½ miles south. The pool is on the right, next to Woodland High School.
- FACILITIES:** Outdoor heated 19-lane, 25-yard pool with locker rooms and rest areas. Warm-up, warm-down/cool-down lanes will be available throughout the time trial. One course of 8 or 10 lanes will be used for the time trial.
- TIMES:** Warm-ups will begin at **9:00 a.m.** Timed finals will begin at **10:00 a.m.**
- RULES:** Current US Swimming/Sierra Nevada Swimming rules will govern the meet, including warm-ups. All events are short course yards and timed finals. Events will be swum from fastest to slowest, with men and women swimming together. Swimmers are required to provide their own lap counter and timers.
- ENTRY LIMITS:** This meet is limited to the first 120 swimmers. Swimmers are limited to a maximum of one (1) event per day. Entries in excess of one per day will not be refunded.
- ELIGIBILITY:** All swimmers must have a current US Swimming registration card. Swimmers who enter **"PENDING"** or **"APPLIED FOR"** must be prepared to present proof of registration or pay the registration fee at time of check-in. Registration will be verified. If a swimmer is found not to be registered at check-in, the Meet Director shall accept the registration at the meet (a \$2 surcharge will be added to the regular registration fee). Duplicate registrations will be refunded by mail.
- ENTRIES:** **MAILED ENTRIES:** Entries must be on a S.A.M.M.S. Consolidated Entry Card or facsimile. Entry cards must be completely filled out and legible; incomplete cards will not be accepted. **NO REFUNDS.** Make checks payable to **Woodland Swim Team.** Mailed entries must be postmarked by midnight Saturday, February 9, 2008 and mailed to:

- ONLINE ENTRIES:** Online entries will be accepted through 11:59 p.m., Saturday, February 16, 2008. Enter at: <http://swimconnection.com/sn/meet/wooddist> to receive an immediate entry confirmation of acceptance via email. The "Billing Info" e-mail should be brought to the meet as proof of entry. Online entry requires payment by credit card using a secure website. Swim Connection LLC charges a processing fee for this service, equal to \$1.00 per swimmer plus 5% of the total Entry Fees. Please note that the processing fee is a separate fee from the Entry Fees described below. Entering online, which requires the payment of this processing fee, is completely voluntary. If you do not wish to pay the processing fee, enter the meet using a mail or hand delivered entry. Online meet entry is not required in order to enter this meet.
- DECK ENTRIES:** Deck entries will be accepted if the cap has not been reached. Please send an email to the meet director with questions about deck entries.
- ENTRY FEES:** \$3.00 per individual event for all entries (includes \$1.00 to Sierra Nevada, \$0.50 to Sierra Nevada Age Group Travel Fund, and \$0.25 to Sierra Nevada National Travel Funds) plus a \$8.00 per swimmer surcharge. Make checks payable to **"Woodland**

Swim Team. Deck Entries are \$3.00 per event plus an \$8.00 per swimmer surcharge. Entry fees are non-refundable.

CHECK-IN: All swimmers must check in with the Clerk of Course. The meet will be deck seeded. Swimmers or their coach must check in at the Clerk of Course. Check-in will start at 9:00 a.m. Sunday. Close of check-in for Event 1 will be promptly at 9:30 a.m. Close of check-in for Event 2 will be no more than 30 minutes before the estimated start time of Event 2. Check-in will be located inside the pool facility at the southwest corner (outside the office) until the start of Event 1. Thereafter, check-in will be located inside the office.

AWARDS: No awards will be offered.

ADMISSION: Free.

MISCELLANEOUS: Refreshments will be available to all working officials and coaches. Snack bar will not be offered.

OFFICIAL'S DRESS: Official attire at this meet will be white shoes, white socks, white polo shirts and navy blue pants/shorts/skirts.

MINIMUM OFFICIALS RULE: Each team shall, by the entry deadline, provide to the meet director or designee a list of officials who have agreed to represent their team during the meet, in accordance with the following table:

11-25	1
26-50	2
51-75	3
76-100	4
>100	5

One half-hour before the scheduled start of each session, the meet referee shall conduct an inventory of officials, and shall compare the number of entries against the number of officials present representing each team. Those teams who have not provided sufficient officials shall have all their swimmers treated as "time-only swimmers" in all aspects of that session.

RESTRICTIONS: Smoking and the use of other tobacco products are prohibited in all areas of the meet venue. The sale and use of alcoholic beverages is prohibited in all areas of meet venue. No pets are allowed. Excessive volume of sound equipment will not be tolerated. NO PERSONAL SHADE STRUCTURES ARE ALLOWED ON DECK.
